1. DESKTOP FONT LICENSE

JHA gives you the right to use the enclosed font on one (1) computer at a single geographic location. It is allowed to access the font through a font management software, the software has to be leased or owned by you. The access to the font management software is limited to the number of licenses in this agreement. Unlicensed computers must not be given access to the font management software. The access is only allowed for you or your legal entity defined in this agreement. The computer can be connected to any number of output devices, such as laser printers, ink jet printers and image setter. This means only one (1) user is allowed to use the license. You need a written license extension to exceed the number of computers and locations. Foundry reserves all rights not expressly granted to you in this agreement.

2. RESTRICTIONS OF USE

- (i) You may embed the JHA font into documents, applications or devices either as a rasterised representation of the font (eg: .jpg, .gif, .png or .tif) or as a subset of the font in formats like .pdf or .eps as long as the document, application or device is distributed in a secure format that permits only the viewing and printing but not the editing of the text or changes of the layout.
- (ii) You need another license (broadcast license/video license) for displaying the font in cinemas, motion pictures, games, on television or cable television, not self hosted streaming services or streaming sides in titles, subtitles or other prominent graphical output. - (iii) You need an other license to integrate the fonts in server hosted digital advertisement (digital advertisement license).

4. ALTERATIONS OF THE FONT

Except as the granted back-up you may not copy, modify, adapt, convert, translate, reverse engineer, decompile, disassemble, alter, or attempt to discover the source code of the font software. If you intend to make alterations to the font, you must obtain the prior written consent of JHA. If the font contains embedding bits that indicate that the font software is only authorised for certain purposes, you may not change or alter the embedding bits.

The license granted herein is effective with the full payment until terminated. JHA has the right to terminate your license immediately if you fail to comply with any term of this Agreement. Upon termination, you must destroy the original and any copies of the font and documentation. The JHA Font Software Desktop License Agreement is subject to German Law. If any part of this agreement is found void and unenforceable, it will not affect the validity of the agreement, which shall remain valid and enforceable according to its terms.
