1. DIGITAL ADVERTISEMENT FONT LICENSE

- (i) The font is licensed, not sold, to you for use only under the terms of this agreement. You are hereby granted a non-exclusive, non-assignable license to create digital advertisements or allow a third party to create digital advertisements on behalf of you a visual content with the embedded font delivered via the internet for display on output devices. 2. RESTRICTIONS OF USE

- (i) You may not embed the font into documents (.eps, .pdf and others), intended for distribution as electronic publications.
- (ii) You may not display images of the font in mobile applications or video games.
- (iii) You may not display images of the font in audiovisual works, in any film or video material (including for the purposes of television broadcasts), including titles and inscriptions.
- (iv) You may not set the font on the server to provide multi-user access.
- (v) You may not use the font on websites using the @ font-face selector.
- (vi) You may not distribute the font files with hardware or software.

3. COPYRIGHT

The font and the design are in their form, structure and code exclusive property of JHA. No ownership rights are granted as a part of this contract. This font is protected by the United States Copyright Law and design laws by nations and international treaties. You agree to treat the font as confidential information and exercise reasonable care to avoid unauthorised distribution. 4. ALTERATIONS OF THE FONT
