1. LICENSED EPUB FONT

You are hereby granted a non-exclusive, non-assignable, non-transferable license (subject to all of the terms and conditions of the agreement) to embed the font into one (1) publication, which is stored and distributed in formats like: edible .pdf documents, epub 2.01, epub 3, and kf8 which contains subsets of the font. Updated versions of publications are free to previous customers and do not need a new license. The license is valid for an unlimited number of copies downloaded. Regional or format variations of a work do not count as separate publications. Magazines, newspapers or other publications with changing content in their issues need a license for each publication. 2. RESTRICTIONS OF USE

4. ALTERATIONS OF THE FONT

Except as the granted back-up you may not copy, modify, adapt, convert, translate, reverse engineer, decompile, disassemble, alter, or attempt to discover the source code of the font software.
